## Academic Programmes

- Our school offers the following Cambridge pathways. In April 2026, the school was granted the status of a CIE-affiliated institution (Centre Number: IA758).

### Pre EY1

- Curriculum planned by VGOS for 2-year-olds that covers the six areas of learning: Personal and Social Development, Communication, Language and Literacy, Mathematics, Understanding of the World, Physical Development and Creative Expression. The focus is on play-based enquiry learning, where students find out about the world through guided teaching.

### EY1, EY2 and EY3

- The Cambridge curriculum covers the six areas of learning: Personal and Social Development, Communication, Language and Literacy, Mathematics, Understanding of the World, Physical Development and Creative Expression.
- **EY1** introduces children to learning through secure, play-based experiences. Children develop listening and attention, early communication, physical coordination and curiosity. They explore numbers, shapes and patterns, begin expressing ideas through mark-making and creativity, and learn to manage emotions, follow routines and build positive relationships with adults and peers.
- **EY2** focuses on developing confident, curious learners through play. Children strengthen communication and early literacy, number sense and problem-solving, scientific exploration, creativity and physical development. They build independence, self-regulation and positive relationships, using talk, movement and mark-making to explore ideas and represent meaning across everyday learning experiences collaboratively.
- **EY3** prepares children for the transition to primary learning through purposeful play and structured experiences. Children develop confident communication, early reading, writing and number skills, problem-solving and scientific thinking. They show independence, self-regulation and collaboration, apply fine and gross motor skills effectively, and use creativity and reflection to explain ideas, make choices and learn across contexts.

### Grades reflect achievement, effort and engagement.

We follow the Cambridge approach to teaching and learning, where assessment is a continuous process that supports each child's growth and development. Our focus is on helping learners build confidence, deepen conceptual understanding and enjoy the process of learning rather than experience pressure about marks or tests.

**In the Primary Grades (1 to 3):** Assessment is largely formative, taking place through daily class interactions, participation and activities. Teachers observe each child closely, provide regular feedback and guide them toward steady progress. This helps ensure that learning is holistic, creative and meaningful.

**In Grades 4 to 7:** We introduce a balance between formative and summative assessment.

- **Formative assessment** continues throughout the term and captures understanding, curiosity and consistent effort.
- **Summative assessment** consists mainly, but not only, of written tasks that allow students to apply what they have learned in a structured format. These are conducted during regular school hours and within the familiar classroom environment to maintain comfort and confidence.

While summative assessments are marked, they should not be viewed as the only measure of a child's ability. They represent one part of the broader learning journey. Our aim is to keep the process stress-free, encouraging students to think, connect and apply concepts rather than revise chapters solely for a test.

As learners progress to senior grades, the balance between formative and summative assessment evolves naturally. This gradual shift helps them build the discipline, clarity and confidence needed for advanced stages of learning—without losing focus on enquiry, reflection and real understanding.

## Teaching and Learning Approach

- Student-centred and enquiry-based learning
- Emphasis on critical thinking and problem-solving
- Use of practical work, projects and discussions
- Integration of digital learning tools

## Homework Policy

Homework reinforces classroom learning and builds independent study habits.

- Assigned regularly according to age and grade
- Parents are encouraged to provide a supportive study environment
- Excessive parental assistance is discouraged

## School Timings and Attendance

### School Hours:

- Monday to Friday (exact times vary by section and in accordance with the orders of the MP Government).

### Attendance:

- Regular attendance is essential for academic success. Attendance above 90% is important, as the Cambridge curriculum builds learning progressively through discussion, enquiry and skill development. Regular attendance ensures continuity, participation in collaborative learning, consistent assessment evidence and timely support. Missing learning experiences limits understanding, slows progress and reduces a learner's ability to meet Cambridge learning objectives with confidence.
- Parents must inform the school of absences in advance where possible.
- Medical certificates may be required for extended absences.

## Student Behaviour and Discipline

We promote positive behaviour based on mutual respect.

Disciplinary actions may include warnings, parent meetings or further consequences as per school policy, which is currently being devised.

## Health, Safety, and Wellbeing

At VIBGYOR World Academy, Nagpur, the health, safety and overall wellbeing of our students are of paramount importance. The school is committed to providing a safe, secure and nurturing environment that supports both physical safety and emotional wellbeing.

### Safe and Secure Campus

- The school maintains a safe and secure campus environment, with appropriate security measures in place.
- Access to the campus is monitored to ensure student safety during school hours.
- Safety protocols are regularly reviewed to align with best practices and regulatory guidelines.

### Health and Medical Support

- First aid facilities are available on campus to address minor injuries or medical needs during school hours.
- Trained staff members are available to provide immediate assistance when required.
- In case of a medical emergency, parents will be informed promptly, and appropriate action will be taken as per school protocol.

## **Medical Information and Parent Responsibility**

- Parents are required to inform the school in writing of any existing medical conditions, allergies or special health needs of their child at the time of admission and whenever there is a change.
- This information helps the school take necessary precautions and provide appropriate care during school hours.

- Age-appropriate wellbeing practices are integrated into the school culture to support students' social and emotional development.

## **Communication with Parents**

To ensure seamless two-way communication, the school uses a dedicated Parent App, currently being developed specifically for VIBGYOR World Academy, Nagpur.

### **Parent App – A Single Window for Communication**

The Parent App serves as a central platform for all school-related communication.

Through the Parent App, parents will receive information such as:

- Important announcements and updates
- Attendance records
- Academic and school-related information

In return, parents are encouraged to communicate directly with teachers and the leadership team as needed. They can also communicate with the school by raising concerns or queries through:

### **Parent Service Requests (PSR)**

The Parent Service Request (PSR) system has been designed to make it easy and structured for parents to raise their concerns.

- All queries and requests can be submitted through the Parent App
- Each request follows a defined, time-bound redressal process
- This ensures clarity, accountability and timely resolution

We request parents to use the PSR system for all formal communication to help the school respond efficiently and effectively.

- Emails and official circulars
- Parent–Teacher Meetings (PTMs)
- School website and newsletters

Parents are encouraged to communicate any concerns respectfully and through appropriate channels to maintain a positive and constructive partnership between the school and home.

## Transport Policy

VIBGYOR World Academy, Nagpur, proposes to offer a safe, secure and comfortable school transport facility for students across the city. The school plans to commence transport services from the academic session 2026–27, subject to operational readiness and route finalisation.

### School Transport Facilities

- The school will provide air-conditioned buses equipped with safety and security features.
- Transport services will be available on designated routes covering all major areas of Nagpur.
- Routes, pick-up points and schedules will be planned based on student requirements and operational feasibility.
- Allocation of transport will be subject to availability and compliance with school transport norms.

### Safety, Supervision and Tracking

- All school buses will be operated by trained and experienced drivers.
- Dedicated caretakers/attendants will be present on each bus to ensure student safety, discipline and support during transit.
- Buses will be equipped with GPS tracking, enabling parents to track the movement of the bus in real time through the Parent App.
- Safety rules and guidelines must be strictly followed by all students using school transport.

### Parent Responsibilities

- Parents must inform the Transport Office in writing of any changes related to:
  - Residential address
  - Pick-up or drop-off details
  - Temporary or permanent discontinuation of transport services
- Parents are responsible for ensuring that students arrive on time at designated pick-up points and are received by an authorised adult at drop-off points, wherever applicable.

### General Guidelines

- Transport fees, route details and operational information will be communicated separately.
- Availing of school transport is optional and subject to the school's transport policy.

- The school reserves the right to modify routes, timings or transport arrangements in the interest of student safety and operational efficiency.
- The school will not be responsible for delays caused by factors beyond its control, such as traffic or weather conditions.

## Fees and Payments

Timely payment of fees is expected to ensure the smooth functioning of academic and administrative processes.

## Withdrawal and Transfer Policy

VIBGYOR World Academy follows a transparent and structured process for student withdrawal and inter-school transfers to ensure clarity, continuity and proper academic planning.

### Inter-VIBGYOR Transfer (IVT)

The Inter-VIBGYOR Transfer (IVT) facility enables parents to transfer their child seamlessly from one VIBGYOR school to another, subject to availability and applicable norms.

- VIBGYOR currently operates 40 schools across 15 cities.
- Parents seeking a transfer within the VIBGYOR group may apply through the IVT process.
- The IVT allows continuity in curriculum, systems, and school culture, making transitions smoother for students.
- Detailed information regarding eligibility, documentation and timelines is available in the IVT Policy, which may be referred to for guidance.

### Withdrawal of Admission

All admission withdrawals are managed through a structured and formal process.

- Parents intending to withdraw their child's admission are required to raise a Parent Service Request (PSR) for withdrawal through the Parent App.
- Upon submission of the PSR, the following two-tier counselling process will be conducted:
  - Counselling with the Head of Admissions
  - Counselling with the Head of the School
- These sessions are intended to understand concerns, explore possible resolutions and support informed decision-making.

### Processing of Withdrawal Requests

- After the counselling sessions, parents will be provided a decision window to confirm their intent to proceed with the withdrawal.
- The withdrawal request will be processed as per school policy once confirmation is received within 7 working days.
- Applicable rules regarding notice period, refunds (if any), and documentation will be governed by the school's withdrawal policy.

Parents are requested to follow the above process to ensure smooth handling of transfers and withdrawals and to avoid any administrative delays.
